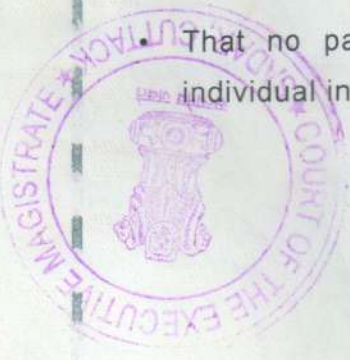
- That St.Xavier's Education Society (under section-25) is a registered Society under Societies Registration Act 1860.
